CONFERENCE PARTICIPANT INFORMATION CLAUSE

In accordance with Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter referred to as the GDPR), we would like to inform you that:

The legal basis for the processing of personal data in this regard is Article 6(1)(e) of the GDPR (processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller), in connection with the Act of 20 July 2018 on Higher Education and Science and the mission pursued by the university on its basis, which is to conduct scientific activity, disseminate scientific achievements, work to raise the scientific level and professional qualifications of participants, shape civic attitudes, and participate in social development and the creation of an innovation-based economy.

Your data will also be processed for the purposes of reporting, control, and archiving related to the Conference, including the fulfilment of accounting and tax obligations arising from the use of public funds (legal basis: Article 6(1)(c) of the GDPR – processing is necessary for compliance with a legal obligation to which the controller is subject), as well as for the possible establishment, exercise, or defence of legal claims, and for analytical and statistical purposes (legal basis: Article 6(1)(f) of the GDPR – processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party).

You may withdraw your consent at any time, which does not affect the lawfulness of processing carried out before its withdrawal,

- 5) We do not intend to transfer your data to third countries (i.e., non-EU countries) or to international organizations,
- 6) Your personal data provided in connection with participation in the Conference will be processed for the period necessary to achieve the purposes specified in point 3), as well as for the period during which the University is required to store financial and accounting documentation and reports related to this event,
- 7) You have the right to request from the data controller access to your personal data, their rectification, erasure, restriction of processing, data portability, as well as the right to request that the processing of your data be stopped,
- 8) You have the right to lodge a complaint with a supervisory authority; the supervisory authority is the President of the Personal Data Protection Office,
- 9) Providing your data is voluntary, but necessary for the purposes for which it was collected; without providing it, participation in the Conference will not be possible,
- 10) We do not intend to use your data for automated decision-making or profiling.
